Students upon official completion of the Counselor Education program, are eligible for a college recommendation for Provisional certification as a School Counselor through the New York state Education Department—Office of Teaching Initiatives (NYSED-OTI). A college recommendation is an online submission to the state from St. Bonaventure University School of Education Office of Educator Preparation Placement and Certification confirming that the student has met certain requirements and officially completed the program. New York State refers to this as the "Approved Teacher Preparation Program" pathway.

Counselor Education/School Counseling students must have a NYSED—TEACH Online Services Account with fingerprint clearance. They must also have completed 3 required state-mandated workshops:

- Child Abuse Identification
- School Violence Prevention
- DASA: Anti-Bullying & Discrimination
- Autism Workshop

# CERTIFICATION OFFICE SCHOOL COUNSELOR CERTIFICATION

NEW YORK STATE PROVISIONAL CERTIFICATION:

Counselor Education/School Counseling students may choose to obtain a provisional certificate as a school Counselor after they have completed the SBU School Counselor Program and have passed Practicum and both semesters of internship. For Counselor Education/School Counseling students that have completed provisional certification on their own, you can go to the New York State Education Department by applying through their TEACH Online Services account using the "Individual Evaluation" pathway.

The following is what NYSED requires using this pathway in order to issue the provisional certificate as a School Counselor:

#### • Pathway: Approved Teacher Preparation Program

Completion of a NYS Registered Program - School Counselor Institutional Recommendation - School Counselor Workshop - Dignity For All Students Act Fingerprint Clearance

<u>Pathway: Individual Evaluation</u>

Education - Bachelors Degree Graduate Coursework - School Counseling - 30 S.H. College Supervised Internship - School Counseling Workshop - Child Abuse Identification Workshop - School Violence Intervention and Prevention Workshop - Dignity For All Students Act Fingerprint Clearance

How to apply for Provisional School Counselor Certificate using the Individual Evaluation Pathway: (www.highered.nysed.gov/tcert/teach)

- 1. Log into the TEACH Online Services Account
- 2. Choose: "Apply for a certificate."
- 3. Update any education or teaching experience
- 4. Area of Interest: Administration & Pupil Personnel Services
- 5. Subject Area: School Counseling
- 6. Grade Level: Pre K-12, All Grades
- 7. Title: School Counselor
- 8. Type of Certificate: Provisional Certificate
- 9. Press ADD and it will ask you for a program code—Select "NO"
- 10. (Another State—Interstate Reciprocity) Select "NO" (for NY only)
- 11. Scroll down and press "NEXT"
- 12. Select to have the "state review your application"
- 13. Answer questions and click "Sign Affidavit"
- 14. Click "Sign Application"
- 15. Checklist for all you must send to the state for the issuance
- 16. Pay the \$100 fee

#### NATIONAL COUNSELOR CERTIFICATION

You must document successful completion of a qualifying master's degree and experience and pass the National Counselor Exam for Licensure and Certification or the National Clinical Mental Health Counseling Exam (www.nbcc.com)

## **NEW YORK STATE LICENSE REQUIREMENTS:**

Counselor Education/Clinical Mental Health Counseling students may choose to obtain a license as a Mental Health Counselor after they have completed the SBU Clinical Mental Health Counselor Program and have passed Practicum and both semesters of internship. For Mental Health Counselors that have completed educational and experience requirements on their own, you can go to the New York State Office of Professions and apply for your license if you have completed all necessary requirements of the State of New York.

To be licensed as a Mental health Counselor in NYS you must:

- Be of good moral character;
- Be at least 21 years of age;
- Meet education requirements;
- Meet experience requirements;
- Meet examination requirements; and
- Complete coursework or training in the identification and reporting of child abuse offered by a NYS approved provider.
