

## Edwin "Ed" Evans '85

Ed Evans became the CEO of West-Camp Press in 2006 when he acquired the company along with his business partner, Dave Marsh. Together they grew the sheet fed printing company into a diverse organization, offering traditional printing, and finishing along with digital and wide format printing. West-Camp was able to grow through a strategy of diversification with enhanced product offerings through acquisitions. West-Camp strengthened its digital offering with the acquisition of Central Ohio Graphics in 2010. West-Camp entered the screen-printing business and expanded the wide format business with the purchase of Columbus-based American Color Scans in 2017, and they expanded into the Cleveland market when it purchased Cleveland Screen Print in 2018. In 2015 West-Camp transitioned into an employee-owned company, allowing Ed to subsequently retire in 2019.

He started in the printing industry when he joined Eastman Kodak in 1985 as a Technical Sales Representative for the Graphic Arts division. He held numerous sales and sales management roles in the company with stops in Atlanta, Indianapolis, Los Angeles, and Chicago, before settling in Columbus in 1992. After Kodak, he was with Xerox Corporation in 2000 in Ohio and then joined West-Camp Press, his long-time client, as Director of Business Development. He had an opportunity to acquire the company in 2006.

Ed was a recognized industry leader in the US and Canda, chairing the Central Advisory Council for the Printing Industries of Ohio-North Kentucky. Ed was recognized with the Franklinton Award in 2021 for his contributions and service to the industry.

Ed is a 1985 graduate of St. Bonaventure University, with a degree in Business Administration. He was a member of the men's basketball team his senior year. He has served on the Board of Directors for the University's SIMM (Students in Money Management) program and attends alumni events. He established the Edwin Evans Family Endowed Scholarship.

Ed and his wife Ann now live in Bonita Springs, FL and enjoy spending summers in the Finger Lakes region. Ann has worked for IBM for over 42 years and is currently Senior Storage Sales Development Leader. She graduated from Indiana University Bloomington in 1981 with a BA in Telecommunications/Business. They have three children, including Will, an alum in '17 (BA) and '20 (MBA). Ed's sister and brother-in-law (Mary Evans and Michael Miller) are 1986 Bona alums.



## James Helms

James Helms is the CEO of Jones Memorial Hospital in Wellsville, NY. It is part of the University of Rochester Medical System. He has been CEO since July 2021 and previously served for 5 1/12 years as CFO, including 2 years in a dual role as CFO for both Jones Memorial and St. James Hospitals, both part of the UR Medical System. He also was the Director of HIM, Revenue Cycle and Corporate Compliance. He is a fellow in the Healthcare Financial Management Association.

At the time of his promotion, here was a quote from one of the media articles about him.

"In eight years at Jones Memorial Hospital, Jim Helms has taken on increased levels of leadership responsibility that have prepared him well to serve as CEO," said Steven I. Goldstein, senior vice president of the University of Rochester Medical Center who oversees UR Medicine regional hospitals, and also serves as president and CEO of Strong Memorial and Highland hospitals in Rochester. Before joining Jones Memorial, he was the Director of Finance and Operations at St. James Hospital in Hornell. His first position there was controller and finance manager. He held CPA positions at Arthur Anderson, as well as working within the telecommunications, and major manufacturing industries before landing in healthcare in 2004.

He also served for 25 years in the U.S. Army Reserve, working throughout global areas of operations, and serving in multiple leadership roles before retiring at the rank of Command Sergeant Major.

He earned his associate in applied science in accounting in 1993 at Alfred State College. Since 2013, he has served as a member of the college's Development Fund Board which serves to raise scholarship funds. He earned his Bachelor of Business Administration in 1995 and MBA in 2018 at SBU. He received a Financial Executives Institute Award and NYS Society of CPAs Award.

He lives in Wellsville, NY with his wife Dena Helms, RN, a care manager at Jones Memorial Hospital. They have two adult children, including James Helms, Jr. who graduated from SBU in 2014.

An avid runner, he has served as chairman of the hospital's annual Ridge Walk & Run fundraiser. He also volunteers his expertise to help American Legion Post 702, serving for more than 10 years as their Finance Officer.

He volunteers and attends the First Trinity Lutheran Church. His past service includes president of the church counsel as well as the Treasurer and Board of Directors member for Homes and Health Care Services.



## Lisa (Melillo) Molinaro '81

Lisa Molinaro gained considerable experience in organizational fund raising for nonprofit organizations in the Fairfield County (CT) region, while supporting her family as a homemaker. She spent three years as president of the St. Gabriel Home-School Association and two years as vice president of St. Cecelia's Home-School Association, as well as five years as co-chair of various fund-raising auctions at both schools.

She is also a former board member of Stamford Catholic Regional Schools and served two years as cochair of the Kinglow-Heywood Thomas fund raiser. She chaired Stamford Hospital's major fund raiser in 2015 and was on the Hospital Foundation Board for many years. Most recently, she served on the Stamford Museum and Nature Center Capital Campaign Committee.

Lisa graduated in 1981 with a BA in Journalism and Mass Communications. Her husband, Sam Molinaro, '80 previously was on SBU's Board of Trustees from 2001-2010. Lisa was the co-chair of the University's 150th Anniversary Campaign which launched publicly in 2005 and culminated during the University's sesquicentennial year of 2008-09.

In 2007, Lisa and Sam contributed a lead gift of \$210,000 to kick off a campaign to replace the existing Reilly Center arena floor with a new, state-of-the-art wood floor. The Molinaros hosted a reception at the Yale Club in New York City on Nov. 30, during which additional funds for the project were secured.

In 2010, the Molinaros joined Steve Watson and Fr. Dan Hurley on the basketball court during the halftime 40th Anniversary ceremony honoring the members of Bona's 1970 Final Four team.

Lisa's sisters are also alumni: Eleonora (Nora) Brittenham '73 and Anne Mulligan '70.

## Fr. Thomas Nairn, OFM

Fr. Thomas Nairn, O.F.M. was born in Cleveland, Ohio on March 18, 1948. He entered the Franciscan Order in 1968 and was ordained a priest in 1975. He earned an M.Div. and M.A. in Theology from the Catholic Theological Union in Chicago and a Ph.D. from the Divinity School of the University of Chicago. His degree is in Christian Theology with a specialization in Christian Ethics. He is a graduate of Quincy College with a degree in psychology. He is a sought-after and globally recognized lecturer on moral theology, especially health care ethics.

From 1980 until 2008, he taught at the Catholic Theological Union at Chicago, becoming the Erica and Harry John Professor of Catholic Theological Ethics. During that time, he was also medical ethics consultant to several Chicago hospitals. In 2008, he became the Senior Director of Theology and Ethics at the Catholic Health Association of the United States, and served in that position until he was elected Provincial Minister of the Sacred Heart Province in 2017. He served as Provincial until October 2023, when the province was integrated into the Our Lady of Guadalupe Province.

Fr. Nairn has published four books and many academic, professional, and popular articles on moral theology, especially in the area of health care ethics. He has taught or lectured in several countries. In 2014, he was appointed by the Vatican's Dicastery for the Laity, the Family and Life as Ecclesiastical Advisor to the International Catholic Committee for Nurses and Health Care Workers, a position he held until 2022. He is a member of numerous professional health care and theological societies and has contributed to many editorial and advisory boards. He has over 100 published articles and publications.

Currently Fr. Nairn serves as vice chair of the Board of Regents of the Franciscan School of Theology. Between elected and ex-officio membership, he will complete 15 consecutive years on Quincy University's Board of Trustees in May 2024. He was chair of this board from 2015-2018. He also served on the Board of Trustees of St. Mary of the Wood College from 1995 to 2004. He has participated in many Boards of Directors and Advisory Boards in the fields of health care, education, and theology.
